Poplar Bluff Regional Medical Center



The Challenge

Poplar Bluff Regional Medical Center initiated its search for a policy management solution in early 2010. As a growing community hospital, Poplar Bluff department managers and executives were increasingly challenged to efficiently update and create policy and procedure documents. Without a centralized system for managing policies, review and approval processes varied greatly among the more than 20 line-of-care departments at Poplar Bluff.

"While documents were circulated electronically, some reviewers preferred to print and edit them manually," said Brenda Bell, Assistant to the CNO for Poplar Bluff. "This part-paper, part-electronic workflow presented numeous version control problems and often resulted in policy reviews lasting several weeks."

Document access was another area Poplar Bluff hoped to address with their new system. Without a centralized, facility-wide location for storing and organizing policy documents, simply locating the correct version of a policy could be a time-consuming challenge in some departments.
